ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 **Sri Venkatachalapathy, Educational Trust, Tiruvannamalai District, Tamilnadu** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **Sri Venkatachalapathy College of Education, Venugopalpuram, Kilnathur Post, Tiruvannamalai-606611, Tamilnadu** for **Secondary(B.Ed)** course of one year duration with an annual intake of **100 (Hundred)** Students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Sri Venkatachalapathy College of Education, Venugopalpuram, Kilnathur Post, Tiruvannamalai-606611, Tamilnadu** for conducting **Secondary(B.Ed)** course of one year duration with an annual intake of **100(Hundred)** students under clause 7(12) of Regulations dated 13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
  - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - iii) The institution will ensure that **Principal and Seven** faculty members duly approved by the affiliating University are in position for an intake of **100** students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
5. The institution shall make admissions only after it obtains affiliation from the examining body.
6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
8. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

ORDER

**WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

**2. AND WHEREAS**, the institution **Sri Venkatachalapathy College of Education, Venugopalapuram, Kilnathur Post, Tiruvannamalai District-606611, Tamilnadu** has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.

**3. AND WHEREAS**, on scrutiny it is found that the institution has not maintained/revaluated the Fixed Deposited Receipts towards Endowment and Reserve Funds.

**4. AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. **The institution shall submit revaluated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.**
- II. **The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.**
- III. **The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.**
- IV. **The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.**

**5. NOW THEREFORE**, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to **Sri Venkatachalapathy College of Education, Venugopalapuram, Kilnathur Post, Tiruvannamalai District-606611, Tamilnadu** for conducting B.Ed programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to submission of revaluated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfilment of the conditions mentioned at II & III herein before 31.10.2015

**6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government, etc, as applicable.**

7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.

CONTINUATION ORDER**

WHEREAS, the recognition u/s 14 of NCTE Act, 1993 was granted to the institution namely **Sri Venkatachalam College of Education, Venugopalpuram, Kilnathur Post, Tiruvannamalai-606611, Tamilnadu** run by **Sri Venkatachalam, Educational Trust, Tiruvannamalai District, TamilNadu** vide Order No. F.SRO/NCTE/B.Ed/2006-2007/14046 dated 02.11.2007 for conducting (Secondary) B.Ed. Course of one-year duration with an annual intake of 100 students.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 12.01.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 30.04.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 408<sup>th</sup> meeting held on 2<sup>nd</sup> March, 2022 taken the decision to issue **Show Cause Notice** to all the colleges of teacher education established even after NCTE Regulations, 2014 at the earliest in order to ascertain the compliance of NCTE Regulations, 2014. Accordingly, a Show Cause Notice was issued to the institution on 09.03.2022. management of the institution has submitted reply of Show Cause Notice vide letter dated 15.09.2022.

4. AND WHEREAS, the SRC in its 414<sup>th</sup> meeting held on 26<sup>th</sup> & 27<sup>th</sup> September 2022 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made were made: -*

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution Sri Venkatachalam College of Education, Survey No. 6/3Q, 7/1A1, 7/1B, Endhal Panchayat, Venugopalpuram, New-bye Pass Road, Tiruvannamalai-606611, Tamilnadu for B.Ed. programme for 2 basic units of 50 students each."*

5. NOW THEREFORE, this order is issued permitting the institution i.e. **Sri Venkatachalam College of Education, Survey No. 6/3Q, 7/1A1, 7/1B, Endhal Panchayat, Venugopalpuram, New-bye Pass Road, Tiruvannamalai-606611, Tamilnadu** run by **Sri Venkatachalam, Educational Trust, Tiruvannamalai District, TamilNadu** for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (2 basic units) of 50 students each subject to fulfilment of the following conditions:-

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.

- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;

11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the institution will render itself vulnerable to




adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.


